



— ISTANBUL — OKAN UNIVERSITY FLIGHT TRAINING

Istanbul Okan University is authorized by the Turkish Directorate General of Civil Aviation (Turkish DGCA) to provide modular flight training. End of these trainings, every Pilot Candidates get the International Civil Aviation Organisation (ICAO) Pilot License which is valid in every country. Some countries may require to convert this license according to their own national regulations.

For all phases of courses, theoretical parts are carried out by İstanbul Okan University Approved Training Organization (Istanbul Okan University ATO). Theoretical Training's location is Istanbul Okan University Bahcelievler Campus (very close to Ataturk Airport).

Flying section of flight training is carried out by Atlantic Flight Academy (AFA, www.afa.aero) which is Istanbul Okan University's partner since 2012. Training aircrafts (Diamond 20 Eclipse, Diamond 40-NG and Diamond 42-NG) and flight instructors are provided by AFA. Diamond aircrafts within the AFA fleet feature IFR flight potential at international standards and Glass Cockpit, which meets the requirements of future flight standards.

Pilot flight trainings are planned and carried out under three main programs as follows;
Applicant select either to the full flight training program or parts of it.



ATPL(A) Course (Full Flight Training including PPL(A) training)

ZERO to ATPL (A) course is relatively the shortest and most effective way to obtain professional pilot qualifications with a high probability of finding airline employment soon after its completion.

Course Duration:
18-24 months

Requirements:

- The minimum starting age for issue of a PPL License is 17.
- Class 1 Medical Certificate

After completion of this course the graduate will be issued with a ICAO CPL/IR and ATPL Frozen license.

Private Pilot License (Airplane) – PPL(A) Course

PPL stands for Private Pilot License and permits the holder to act as a Pilot-in-Command for non-commercial purposes onboard a Single Engine Piston airplane under VMC (Visual Meteorological Conditions).

By having this license and its privileges, you will be taking the first step into professional flight life. To become an airline pilot in the modular education system, it is necessary to have PPL.

3 months (approximately)

Requirements:

- Minimum 17 years old
- Minimum Class 2 Medical Certificate

Flying instruction: 46.30 hours

- 35 hours flight instructions
- 10 hours student solo flight
- 1.30 PPL checkride.



Airline Transport Pilot License - ATPL (A) (for PPL(A) Holders) Course

If you wish to become a commercial pilot there are a number of ways to go about it. At Istanbul Okan University, modular system of training is applied. This enables the student to be much more flexible in the way in which they train. It can be spread over a longer time span and can be carried out in any order he or she wishes. And importantly the cost is much lower.

Course Duration:

12-18 months (approx.)

Requirements:

- The minimum age for issue of a CPL License is 18.
- Hold a PPL(A) issued in accordance with ICAO Annex 1.
- Class 1 Medical Certificate

After completion of this course, students hold ICAO CPL/IR and ATPL Frozen license.

Holder of this license are eligible for employment as airline pilot.
